Renter understands and agrees that this Rental Agreement may not be approved, and that the Board may revoke this Rental Agreement at any time and without notice due to emergencies that supersede scheduled events, or based on facts brought to their attention which indicate that said use will not be in compliance with the Use Policy currently in effect.
- 6. The Clark Rec Board is not responsible for lost or stolen personal items at the facility.
- 7. Renter will keep said premises in good condition and will be responsible for all damages incurred according to the Use Policy currently in effect.
- 8. It is further understood and agreed by and between the Board and Renter that in the event of breach or default by the Renter, all attorney fees, court costs and other expenses incurred by such default or breach will be the responsibility of the Renter.

Prior to leaving, Renter must complete the following regardless of payment or waiver of cleaning fees:

- 1) Remove from the premises any materials, **food**, literature or other items used at the event
- 2) All tables and chairs used must be clean and returned neatly to their storage area
- 3) Wipe down toilets
- 4) Lock restroom doors, both inside door and outside door
- 5) Turn off all lights
- 6) Place all trash bags in dumpster and replace liners in trash cans
- 7) Thoroughly clean the area of the facility that you used
- 8) Check outside area and clean up and discard any trash from the event

Arena/Rodeo Grounds Rental:

- 1. Renter will be responsible for having all participants in the event sign a waiver holding the CPRP harmless for any accidents or injuries.
- 2. Renter's cleaning deposit will be returned after a satisfactory clean-up has been completed and a CPRP representative and the renter have done an assessment.
